2008 WESTERN OPEN CHARLOTTE, NC FEBRUARY 8-10, 2008

The competition pool is a 50-meter pool divided by 2 bulkheads for use of two 8 lane 25 yard pools. Non-turbulent lane lines and Paragon starting blocks. Minimum depth is 6 ft. at scoreboard end and 13 ft. at the deep end. Seating for 1000 people with ample parking areas within 100 yards of the facility. Colorado 5000 electronic timing system with scoreboard will be used.

Rules: The meet will be conducted in accordance with the current USA Swimming Code and the NCS Official Handbook and NCS Safety Program, except where rules therein are optional and exceptions are herein stated.

Classifications: Age Groups: 8 & under (25s), 10 & under, 12 & under, 13-14, and Senior

This meet is open to all USA Swimming, Inc. registered swimmers and teams.

Eligibility: All swimmers must be registered with USA Swimming, Inc.

There are no minimum time standards for events less than or equal to 100 yards in distance. Events 200 yards and greater require a "B" qualifying time or faster. 8 & under, 10 & under, 12 & under, and 13-14 swimmers may not swim events in which they have achieved the qualifying times required for the 2008 NCS 14 & Under Championships. Likewise, Senior event swimmers may not swim events in which they have achieved the qualifying times required for the 2008 NCS Senior Championships.

Swimmers, 14 and Under, who have qualifying times in their age group can swim in the Senior events so long as they swim in only Senior events for the entire meet.

Entries: It is required that meet entries be submitted in Hy-Tek Team Manager format for import directly into the Hy-Tek Meet Manager Program, preferably via email. The event file will be posted on our web site at www.teamcharlotte.com

All methods of entry must include the entry summary sheet and printed output listing the swimmers first and last name, swimmer's age as of February 8, 2008, and specified events and entry times. There will be no "On Deck" registration available at this meet. Only properly completed forms with payment of all fees will be accepted.

- Entry Limit:** Each swimmer may enter up to 5 individual events per day and no more than 10 events total. Total number of entries accepted will be limited due to facility space limitations. Entries will be accepted on a first come first served basis. We reserve the right to combine boys/girls heats when deemed necessary and/or limit the number of entries accepted in the 400 IM, 500 and 1000 free.
- Entry Deadline:** **Entries must be received by Tuesday, January 29, 2008.** NO telephone or fax entries will be accepted. Please return entries as soon as possible. Total number of entries accepted will be limited due to facility space limitations. If space is available, late entries may be accepted at the discretion of the Meet Director and may not be seeded. Late entries will be charged **DOUBLE** the entry fee.

\$5.00 per swimmer Facility Surcharge

- Order of Events:** See below for order. All events will be timed finals. No relays.
- Format:** This meet will run from both ends of the pool. You will be informed at the Coaches' Meeting as to the meet format. Breaks will be taken at the meet referee's discretion.
- Check-In:** Positive check-in is required for 400 IM, 500 Free and 1000 Free. 500 Free check-in is 30 minutes before completion of warm-up. 1000 Free check-in is before completion of 100 Fly. 400 IM check-in is before completion of 200 Fly. 400 IM, 500 Free and 1000 Free swimmers must provide a timer and lap counter. **The North Carolina Swimming scratch rule will be in effect**
- Awards:** 1-8 place ribbons.
- Warm-up:** In accordance with the NCS Safety Program, there will be a strict warm-up procedure. It will be followed by all swimmers and coaches attending the meet. The warm ups will be divided into two sessions, each approximately 40 minutes in duration. Warm up information will be distributed via email. The Meet Director will establish and announce the procedure during the Coaches Meeting prior to the start of Friday PM session warm-ups.
- Time Schedule:** Friday: PM Warm-up – 4:00 – 5:25, Timed Finals – 5:30 PM
Saturday: AM Warm-up - 7:30 – 8:55, Timed Finals – 9:00 AM

PM Warm-up - 1:00 – 2:25, Timed Finals - 2:30 PM
- Safety:** The NCS Safety Program is in effect for this meet. Coaches are advised to closely supervise their swimmers at ALL times. All teams are expected to have

at least one (1) certified coach on the deck to monitor their swimmers. Each coach is responsible for monitoring his/her team's activities in this area. NO running or horseplay will be tolerated.

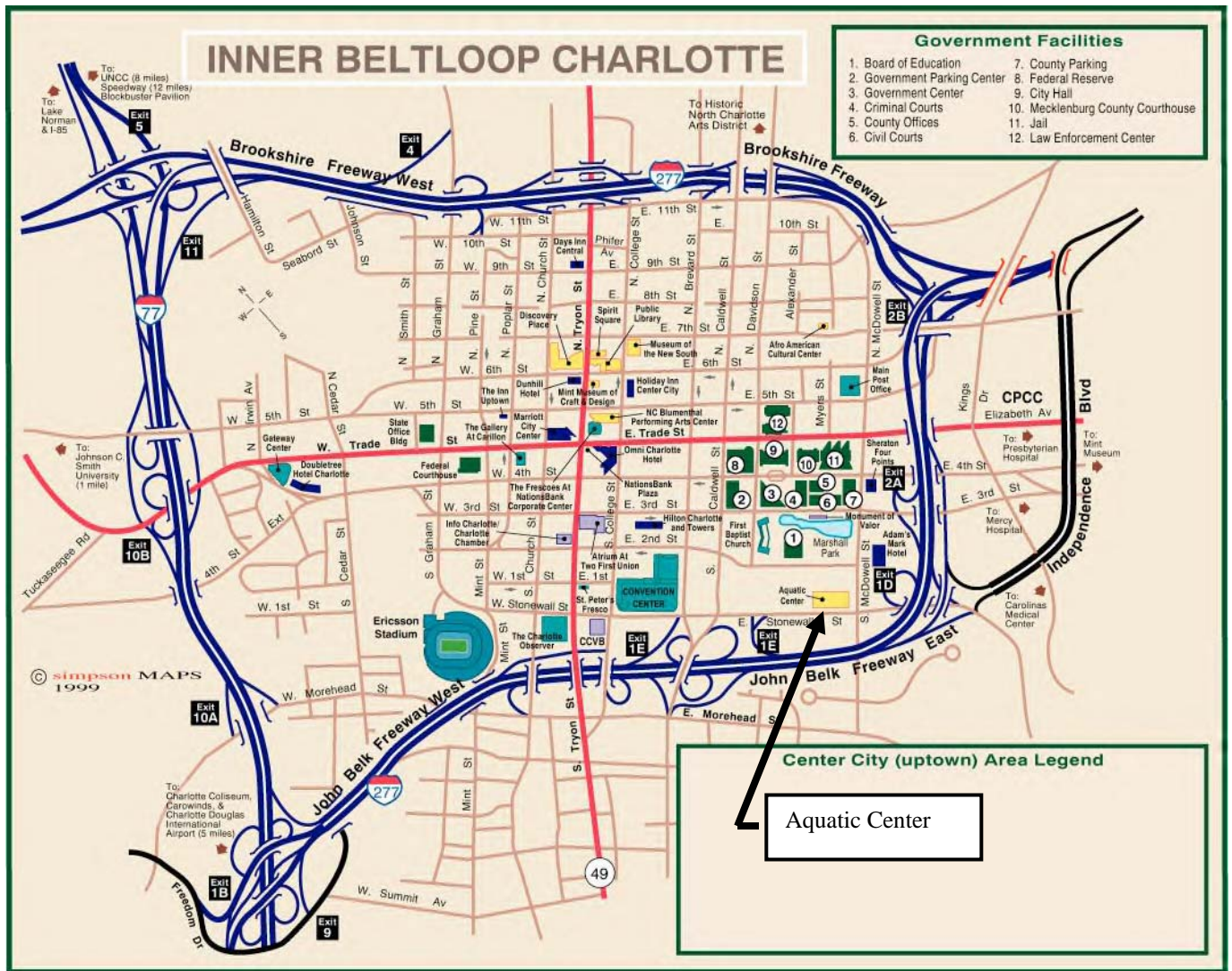

From Southbound I-77: Take I-77 South to the John Belk Freeway. Go East on John Belk Freeway (I-277). Proceed East on the John Belk Freeway. Take the Caldwell Street exit. Proceed North on Caldwell Street for two blocks. Take a right on 2nd Street. The Mecklenburg County Aquatic Center is approximately ¼ mile on the right. Parking is available across the street from the Aquatic Center at the Mecklenburg County Education Center or behind the Aquatic Center in the Walton lot.

From Northbound I-77: Take I-77 North to the John Belk Freeway. Go East on John Belk Freeway (I-277). Proceed East on the John Belk Freeway. Take the Caldwell Street exit. Proceed North on Caldwell Street for two blocks. Take a right on 2nd Street. The Mecklenburg County Aquatic Center is approximately ¼ mile on the right. Parking is available across the street from the Aquatic Center at the Mecklenburg County Education Center or behind the Aquatic Center in the Walton lot.

Limited parking is available in the Aquatic Center parking lot. Additional parking is available across the street at the Mecklenburg County Education Center or behind the Aquatic Center in the Walton lot. Parking is not allowed in the Education Center or Walton lots prior to 5:10 PM on Friday. Plan to arrive after 5:10 PM on Friday.
