## Last Splash Open

*February 9 - 10, 2008*

### Location

**Sportsplex in Hillsborough, NC**

- SANCTION:** Held under the sanction of USA Swimming, Inc., issued by North Carolina Swimming, Inc. Sanction No. #NC08026
- FACILITY:** The Sportsplex is a ten lane, 25-yard course with non-turbulent lane ropes, the Colorado Electronic Timing System with horn and strobe start will be used. There is a separate pool for continuous warm up and cool down.
- RULES:** The meet will be conducted in accordance with the USA Swimming Rules and Regulations and the NC Official Handbook and NCS Safety program, except where the rules therein are optional and exceptions are herein stated.
- CLASSIFICATION:** Age Groups: 10 & Under, 12 & Under, and 13-18
- ELIGIBILITY:** All swimmers must be registered with USA Swimming, Inc.
- All swimmers must be registered with USA Swimming, Inc. Swimmers 14-under who have achieved a NCS State Meet Qualifying standard in an event will not be allowed to swim that event. Swimmers, regardless of their age, will not be able to enter an 18-under event in which they have already achieved a NCS Senior Championship qualifying time. Swimmers aging up to a new age classification between this meet and the North Carolina 14-under Age Group Championship meet may elect to enter event(s) in the older age group. 12-under Swimmers who need time cuts for Age Group sectionals in the 200's of fly, back and breast and the 400 IM and 1650 free may enter the 18-under events at this meet.
- All 500 and 1650 swimmers must provide their own timers and counters.**
- ENTRIES:** Entries must be submitted in Hy-Tek Team Manager format.
- Entry file maybe submitted by e-mail to [tbrewer441@aol.com](mailto:tbrewer441@aol.com). A print out listing the individual swimmers and their events, all other requested information and payment of entry fees must be submitted for your entry to be considered complete.
- ENTRY LIMIT:** The Meet Director reserves the right to limit entries to 500 swimmers properly registered.
- Entries are accepted in order of receipt. Only properly completed entry forms with payment of all fees will be accepted. Entry forms and summary sheets not properly completed or submitted without payment will be considered not received.
- Swimmers are limited to five individual events per day. A swimmer entered in too many events will be dropped from the first event that is over the limit.

**ENTRY DEADLINE:** Midnight, **Wednesday, January 30, 2008**

Late entries will be accepted only at the discretion of the Meet Director. Late entries may not be seeded. We reserve the right to limit or suspend the addition of swimmers or heats to accommodate late entries. Late entries will be charged double fees.

Telephone entries will not be accepted. We will accept calls to correct or modify entries mailed and received prior to the entry deadline.

**ORDER OF EVENTS:** See attached. Please note the 11-12 boys are swimming in the afternoon sessions.

**CHECK IN:** Positive check in is required for 400 IM, 500 Free, and the 1650 Free. Check in must be done 30 minutes before the end of warm-ups.

**AWARDS:** Ribbons - 1st - 8th Place

**SCORING:** This meet will not be scored.

**SAFETY:** The NCS safety program is in effect for this meet. Coaches are advised to closely supervise their swimmers at all times. No running or horseplay will be tolerated. Anyone failing to comply with safety request can forfeit their privilege to participate.

**USA MEMBERSHIP:** Coaches must present a current USA Swimming, Inc. membership card to the Meet Director to receive their entry package and must display their membership card at all times that they are on deck.

**COACHES MEETING:** The meet referee may call for a coaches meeting if it is determined one is needed.

First 30 Minutes - General Warm-Up In All Lanes. No Diving.

Last 30 Minutes - Specific Warm-Up. Lanes will be assigned
