**SANCTION:** Held under the sanction of USA Swimming, Inc., issued by North Carolina Swimming, Inc. Sanction No. NC08096 Rev 1 (**NOTE CHANGE OF LOCATION**)

**FACILITY:** The John Dewey Pool is an eight lane, 25-yard course with non-turbulent lane ropes. The Colorado Electronic Timing System with horn and strobe start will be used. There is a small diving well available for warm down after swimming events.

**RULES:** The meet will be conducted in accordance with the USA Swimming Rules and Regulations and the NC Official Handbook and NCS Safety program, except where the rules therein are optional and exceptions are herein stated

**ELIGIBILITY:** All swimmers must be registered with USA Swimming, Inc.

**ENTRIES:** Entries must be submitted in Hy-Tek Team Manager format.

Entry file may be submitted by e-mail to [tbrewer441@aol.com](mailto:tbrewer441@aol.com). A print out listing the individual swimmers and their events, all other requested information and payment of entry fees must be submitted for your entry to be considered complete.

All relay only swimmers, including alternates, must be entered on the submitted entry disk or listed on the meet entry forms and pay the NCS travel fund surcharge of \$2.00 and the \$5.00 Facility charge.

**ENTRY**

**LIMIT:** The Meet Director reserves the right to limit entries to 400 swimmers properly registered.

Swimmers are limited to five individual and one relay event per day. A swimmer entered in too many events will be dropped from the first event that is over the limit.

The 1000 Freestyle is further limited to 10 heats equally divided between Women and Men.

**ENTRY**

**DEADLINE:** Midnight, Wednesday, November 12, 2008.

Late entries will be accepted only at the discretion of the Meet Director. Late entries may not be seeded. We reserve the right to limit or suspend the addition of swimmers or heats to accommodate late entries. Late entries will be charged double fees.

**ENTRY FEES:** \$2.50 per Individual Event  
\$8.00 per Relay Event  
\$2.00 per Swimmer - NC Travel Fund (Includes Relay Only Swimmers)  
\$5.00 Facility Charge per swimmer

**SEEDING:** With the exception of the 400 IM, 500 Free, and 1000 Free, all events will be pre-seeded. The 400 IM and 500 Free will swim fastest to slowest. The 1000 Free will swim fastest to slowest, alternating women and men.

**CHECK-IN:** In order to be seeded into the 400 IM, 500 Free, and 1000 Free, swimmers must check in with the Clerk of Course. Clerk of Course will close for check-in 30 minutes prior to the beginning of each session.

**AWARDS:** Individual Ribbons: 1st - 8th Place by age group  
Relay Ribbons: 1st Place

**SCORING:** This meet will not be scored.

**SAFETY:** The NCS safety program is in effect for this meet. Coaches are advised to closely supervise their swimmers at all times. No running or horseplay will be tolerated. Anyone failing to comply with safety request may forfeit his or her privilege to participate.

**MEMBERSHIP:**  
All coaches and officials on deck must be registered and certified with USA Swimming. Meet Management will require all coaches and officials to show proof of certification/ registration. Coaches and officials shall prominently display their registration cards while on deck.
