HOST: Harnett County Aquatic Club

SANCTION: Held under the sanction of USA Swimming, Inc., issued by North Carolina Swimming, Inc., Sanction#NC08103

FACILITY: Campbell University Nathan Johnson Natatorium

The pool is an 8 lane 25-yard course with non-turbulent lane markers, 30" deck anchored starting blocks, and a 12 foot depth at the starting end. Electronic timing will be in use (IST timing interface, IST 9 line scoreboard, Colorado Touch Pads, and one backup button) along with 2 watches in each of 8 lanes used for competition. There will not be warm-up and cool down facilities available.

Spectator seating at this facility will be limited. There will be portable bleacher seating for ~150 people at one end of the facility. There will be a classroom adjacent to the pool available for additional seating. Teams will be allowed to place tents adjacent to the facility. Concessions will be provided in the front lobby. Boys and girls locker rooms will be available.

There is no smoking allowed inside the facility. All persons in the official's or coaches' area must be card carrying coaches, officials, registered swimmers, or volunteer workers. Please observe all posted facility rules. Violators may be removed or barred from competition for failure to adhere to facility rules.

In an effort to alleviate warm-up congestion, the pool will be available for warm-ups at 7:00am.

CLASSIFICATION: This is a closed invitational swim meet. Only NCS, Inc. registered swimmers representing current league member teams may participate.

RULES: This meet will be conducted in accordance with the current USA Swimming code and the NCS Safety Program, except where the rules therein are optional and exceptions are herein stated.

FORMAT: This meet will be a timed finals format.

CHECK-IN: All events longer than 400 yards and relays will require positive check-in by the conclusion of warm-ups on the day they will be swum.

RELAYS: Teams may enter as many relays as they want.
ENTRIES: Entries should be submitted electronically and be accompanied with a hard-copy of entries.

INDIVIDUAL AND RELAY ENTRIES: Swimmers are limited to 4 individual events and 1 relay per day of the meet. A swimmer entered in too many events will be dropped from each event over the limit
