Location: Isothermal Community College Pool

Site Information: Competition pool; 25 yards, 6 lanes (7' wide), indoor pool. The pool depth ranges from 3.5 feet to 10 feet at the starting end and is equipped with 4-inch anti-wave lane lines. Colorado Timing electronic timing/starting system will be used.

Rules: The meet will be conducted in accordance with the current USA Swimming Code and NCS Safety Program, except where rules therein are optional and exceptions are herein stated.

Classification: Closed League Meet

Eligibility: All swimmers must be registered with USA Swimming, Inc. and members of BRSL.

Entries: Entries must be submitted using HY-TEK's Team Manager. Entries may be mailed on diskette or e-mailed. List ages of swimmers as of March 7, 2009.

Entry Limit: Swimmers are limited to three individual events and two relays.

Entry Deadline: Entries must be received by midnight **Friday, February 27, 2009**. Late entries will be at the discretion of the Meet Director and at a cost of \$10 per late entry.

Entry Fees: \$10.00 per swimmer. (Includes all event entries and facility fees) Make checks payable to: **Rutherford County Swim Team**

Relay Ribbons – 1st-6th Place

Warm-Ups: Warm-ups begin at **8:00 am**. Meet starts at **9:00 am**. Warm-ups will be conducted according to the NCS Safety Program and shall be supervised.
