**Saturday, January 24, 2009**

- Sanction:** Held under the Sanction of USA Swimming, Inc., issued by North Carolina Swimming, Inc. Sanction # NC09016 Rev 1
- Host Team:** YBAC Hurricanes
- Pool:** Maynard Aquatic Center, 1402 Overbrook Drive, Burlington, NC 27215 (336) 229-3161.
- Driving Directions:** **From Greensboro** - Take 40 East, Exit at 143, turn left on to Alamance Road, turn right onto S. Church Street, at the Ham's Restaurant turn right onto Overbrook Road. Drive to cul-de-sac and then turn right into BAC parking lot.
- From Mebane** - Take 40 West, Exit a 143, turn right onto Alamance Road – follow the directions above.
- Facility:** 25 Yard 6 lane pool, with additional areas for warm-up/ warm down.
- Times:** Warm-ups 9:00 AM, Start 10:00 AM
- Warm-ups:** Warm-up lane assignments will be determined after the entries have been received and will be included in the coaches' packets.
- Coaches Meeting:** Coaches meeting will be held on Saturday at 9:45am in the front reception area lobby
- Classification:** Meet is classified as an 8 & Under Meet.
- Eligibility:** Open to all USA Swimming registered 8 year old and younger swimmers & members of the YBAC Hurricanes 9 & over. Age on January 24, 2009 will determine age for the entire meet. All swimmers must be registered with USA Swimming, Inc.
- Format:** Timed final meet, with all events pre-seeded.
- Rules:** The meet will be conducted in accordance with the current USA Swimming Code, the NCS Official Handbook, and the NCS Safety Program, except where rules therein are optional and exceptions are herein stated.
- All coaches and officials on deck must be registered and certified with USA Swimming. Meet management will require all coaches and officials to show proof of certification / registration. Coaches and officials shall prominently display their registration cards while on deck.
- Entries:** Submitted entries by Hy-Tek entry file via e-mail to: [swimcoachdjm@yahoo.com](mailto:swimcoachdjm@yahoo.com). Mail: 1) a printout listing individual swimmers, their events, USA-S number, age and entry times. 2) Attached summary sheet with fees. Meet Management reserves the right to combine any events as needed and reserves the right to limit the number of heats or entries in any event to control meet timelines. This includes events with combined age groups. If meet entries must be limited, they will be accepted in the order in which final and completely correct entry files and complete payment of all entry fees are received until the meet capacity is reached. 'NO TIME' (NT) entries WILL be accepted. All relay-only swimmers including alternates must be listed and pay the swimmer surcharges.
- Entry Limit:** Swimmers are limited to 5 individual events and 3 relays each day.
- Entry Deadline** Entries are due by the end of the day on Wednesday, January 14, 2009. Late entries will be accepted only at the discretion of the Meet Director. Late entries may not be seeded. Late entries will be charged double fees. No telephone or fax entries will be accepted.

- Entry Fees:** \$2.00 for Each Individual Event, \$8.00 for Relays, \$7.00 per swimmer surcharge (\$2.00 NCS Travel Fund Surcharge & \$5.00 Facility Charge). **Make one team check payable to: Alamance County YMCA. Entry fees are not refundable.**

- Safety:** The NCS Safety Program is in effect for this meet. Coaches are advised to closely supervise their swimmers at all times. NO running or horseplay will be tolerated. Coaches must present a current USA Swimming membership card to the Meet Director to receive their entry package and must display their membership card at all times that they are on deck.
- Awards:** Ribbons will be awarded: 1<sup>st</sup> through 6<sup>th</sup> place
- Scoring:** Top 6 places will receive scores – 7-5-4-3-2-1 (relays double)
- Results:** Individual team results will be emailed to each club following the completion of the meet. Complete results will also be posted on the YBAC website: [www.acymca.org](http://www.acymca.org)
- Official's Briefings:** Official's briefings will be held in the hospitality room 20 minutes after the start of warm-ups for each session.
