

**YBAC Hurricanes Fall Invitational
November 20& 21 2010**

- Sanction:** Held under the Sanction of USA Swimming, Inc., issued by North Carolina Swimming, Inc. Sanction # NC10123.
- Host Team:** YBAC Hurricanes
- Pool:** Maynard Aquatic Center, 1402 Overbrook Drive, Burlington, NC 27215 (336) 229-3161.
- Driving Directions:** **From Greensboro** - Take 40 East, Exit at 143, turn left on to Alamance Road, turn right onto S. Church Street, at the Ham's Restaurant turn right onto Overbrook Road. Drive to cul-de-sac and then turn right into BAC parking lot.
From Mebane - Take 40 West, Exit a 143, turn right onto Alamance Road, turn right onto S. Church Street, at the Ham's Restaurant turn right onto Overbrook Road. Drive to cul-de-sac and then turn right into BAC parking lot.
- Facility:** Competition Pool is a 6 lane 25 yard course with 7ft lanes divided by anti-turbulent lane markers. Pool depth ranges from 4.5 ft to 5.5 feet at both starting and turn ends with Paddock starting blocks. Semi-automatic timing with pushbuttons is used along with backup watches in each lane and a single line Daktronics score board. Separate warm up and cool down facilities are available. This facility is not on the USA Swimming certified list.
- Times:** Sat & Sun AM - Warm-ups: 8:00 AM, Start: 9:00 AM; The host team reserves the right to separate sessions in to two sessions if entries warrant
- Warm-ups:** Warm-up lane assignments will be determined after the entries have been received and will be included in the coaches' packets.
- Coaches Meeting:** Coaches meeting will be held on Saturday at 7:45am in the front reception area lobby
- Classification:** Meet is classified as an Age Group/Senior Meet
- Eligibility:** Open to all USA Swimming registered swimmers. Age on November 20, 2010 will determine age for the entire meet. All swimmers must be registered with USA Swimming, Inc.
- Format:** Timed Final meet, with all events pre-seeded
- Rules:** The meet will be conducted in accordance with the current USA Swimming Code, the NCS Official Handbook, and the NCS Safety Program, except where rules therein are optional and exceptions are herein stated.
- Entries:** Submitted entries by Hy-Tek entry file via e-mail to: swimcoachdjm@yahoo.com. Mail: 1) a printout listing individual swimmers, their events, USA-S number, age and entry times. 2) Attached summary sheet with fees. Meet Management reserves the right to combine any events as needed and reserves the right to limit the number of heats or entries in any event to control meet timelines. This includes events with combined age groups. If meet entries must be limited, they will be accepted in the order in which final and completely correct entry files and complete payment of all entry fees are received until the meet capacity is reached. 'NO TIME' (NT) entries WILL be accepted. There will be no on deck registration at this meet. All relay-only swimmers including alternates must be listed and pay the swimmer surcharges.
- Entry Limit:** Swimmers are limited to 5 individual events and 1 relay each day.
- Entry Deadline** Entries are due by the end of the day on Wednesday, November 10, 2010. Late entries will be accepted only at the discretion of the Meet Director. Late entries may not be seeded. Late entries will be charged double fees. No telephone or fax entries will be accepted.

- Entry Fees:** \$2.50 for Each Individual Event, \$8.00 for Relays, \$10.00 per swimmer surcharge (\$4.00 NCS Travel Fund Surcharge & \$6.00 Facility Charge)
- Make one team check payable to: Alamance County YMCA. Entry fees are not refundable.**
- Mail entries to:** Alamance County YMCA - Attn: David McDevitt, 1346 S Main St., Burlington NC 27215; swimcoachdjm@yahoo.com. Do not send entries in a manner that requires signature upon delivery. Email verification of receipt will be sent.
- Safety:** The NCS Safety Program is in effect for this meet. Coaches are advised to closely supervise their swimmers at all times. NO running or horseplay will be tolerated. Coaches must present a current USA Swimming membership card to the Meet Director to receive their entry package and must display their membership card at all times that they are on deck.
- Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- YBAC welcomes all swimmers with disabilities as described in the USA Swimming Rules and Regulations, Article 105, to participate in our meets. Coaches entering swimmers with disabilities that require any accommodations are required to provide advance notice in writing to the meet director by the entry deadline accompanying their meet entry file, including the need for any personal assistants required and/or registered service animals. Failure to provide advance notice may limit YBAC's ability to accommodate all requests.
- Awards:** Ribbons will be awarded: 1st through 8th place for "A", "BB", "B" & "C" times; Best times ribbons will be awarded. Most Improved Awards will be presented to swimmers based on Hy-Tek scoring system
- Scoring:** No team scoring for this meet
- Results:** Individual team results will be emailed to each club following the completion of the meet. Complete results will also be posted on the YBAC website: www.acymca.org
- Official's Briefings:** Official's briefings will be held in the hospitality room 20 minutes after the start of warm-ups for each session.
