**SANCTION:** Held under the sanction of USA Swimming, Inc., issued by North Carolina Swimming, Inc. Sanction No. NC11010.

**HOST:** The Greensboro Swimming Association. [www.GSAswim.org](http://www.GSAswim.org)

**FACILITY:** The Triangle Sportsplex pool is an 11-lane, 25-yard pool with non-turbulent lane markers and deck-anchored starting blocks. It is 6' deep at the starting end. The Colorado Timing system with horn and strobe start will be used along with watches in each of the 10 8' wide lanes used for competition. In addition to the competition pool, there is a separate warm-up/warm-down pool for continuous use throughout the meet. The pool is not certified to USA Swimming standards. Industrial fans will be used to further improve air circulation. Locker rooms are available. The facility has seating for about 400 plus room for folding chairs. Spectators are not allowed on the competition deck at any time.

**RULES:** The meet will be conducted in accordance with the USA Swimming Rules and Regulations and the NCS Official Handbook and NCS Safety program, except where the rules therein are optional and exceptions are herein stated.

**CLASSIFICATION:**  
Age Group/Senior Timed Finals

**ELIGIBILITY:** All swimmers must be registered with USA Swimming. Any swimmer entered in the meet unaccompanied by a USA Swimming member coach must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

GSA welcomes all swimmers with disabilities as described in the USA Swimming Rules and Regulations, Article 105, to participate in our meets. Coaches entering swimmers with disabilities that require any accommodations are required to provide advance notice in writing to the meet director by the entry deadline accompanying their meet entry file, including the need for any personal assistants required and/or registered service animals. Failure to provide advance notice may limit GSA's ability to accommodate all requests.

**ENTRIES:** Entries must be submitted in Hy-Tek Team Manager format.

Entry file may be submitted by email (preferred) or by mail. Telephone entries will not be accepted. Complete entries will be accepted in order of receipt. Properly completed entry forms must be submitted along with all other requested information and payment of all fees for entries to be considered complete. The Meet Director will accept calls to correct or modify entries received prior to the entry deadline.

**ENTRY**

**LIMIT:** Swimmers are limited to five individual events per day. A swimmer entered in too many events will be dropped from the first event that is over the limit.

No breaks will be offered other than those published in the meet information. Please enter swimmers accordingly.

The Meet Director reserves the right to limit entries to comply with the NCS 4-Hour Rule.

**ENTRY**

**DEADLINE:** Midnight, Wednesday, February 2, 2011.

**LATE**

**ENTRIES:** Late entries will be accepted only at the discretion of the Meet Director. Late entries may not be seeded. The Meet Director reserves the right to limit or suspend the addition of swimmers or heats to accommodate late entries. Late entries will be charged double fees.

**SEEDING AND  
POSITIVE**

**CHECK IN:** The 400 IM, 500 Free and 1650 Free will be deck seeded. In order to be deck seeded into the 400 IM, 500 Free and 1650 Free, swimmers must positively check in with the Clerk of Course. Clerk of Course will close for check in 30 minutes prior to the end of warm ups for each session.

We reserve the right to limit entries in the 1650 Free to the top 20 fastest women and top 20 fastest men. In this scenario, swimmers entered with no time (NT) will not be seeded unless all positively checked in NT swimmers can be accommodated within the four heats.

The 400 IM and age group 500 Free will be swum in event order slowest to fastest. The Open 500 Frees will be swum fastest to slowest. The 1650 Free will be swum fastest to slowest alternating women and men. If timeline permits, the option to swim the 1650 at the conclusion of the Saturday morning session may be offered to 11-12 boys.

**All swimmers in 500 Free and 1650 Free must provide their own timers and counters.**

**SCRATCH**

**PENALTIES:** Swimmers failing to positively check in for deck seeded events will be scratched from the event. Swimmers who positively check in but do not swim will be scratched from their next event of the meet.

**AWARDS:** Individual Ribbons: 1st - 8th Place by age group

**SCORING:** This meet will not be scored.

**SAFETY:** The NCS safety program is in effect for this meet. Coaches are advised to closely supervise their swimmers at all times. No running or horseplay will be tolerated. Anyone failing to comply with safety request may forfeit his or her privilege to participate.

**MEMBERSHIP:**

All coaches and officials on deck must be registered with and certified by USA Swimming. All coaches and officials are required to show proof of registration/certification. Coaches and officials shall prominently display their 2011 USAS registration cards while on deck.

**COACHES'**

**MEETING:** A coaches' meeting may be held 10 minutes prior to the beginning of each Saturday warm up session at the referee's discretion.

**OFFICIALS'**

**MEETING:** We welcome all certified USA Swimming officials and apprentices on deck. Please ask officials to email the meet referee if they plan to volunteer. An officials' meeting will be held at 7:15 am and at 12:15 pm each day in the hospitality room.

We strongly recommend each team assign a marshal to monitor warm-up sessions in addition to host team marshal. Continuous warm-up will be monitored throughout meet.

**WARM UP**

**PROCEDURE:** Warm-up procedure and lane assignments as follows:

First 25 Minutes - General warm-up. Feet first entry. No diving. Lane assignments will be announced and posted.

Last 25 Minutes - Specific warm-up.

Lanes 1 and 10 - Push off beginning at start end of pool. Circle swim only. No diving.

Lanes 2 and 9- Dive start only. Swim on length only. Start from start end only.

Lanes 3, 4, 5, 6, 7, 8- General warm-up only. No diving.

Warm-Up Procedure may be modified on deck by the Referee to adjust for existing conditions.

**SESSION SCHEDULE:**

Saturday & Sunday Morning Sessions

Warm-Ups begin at 7:00 AM and end at 7:50 AM

Timed Finals begin at 8:00 AM

Saturday & Sunday Afternoon Sessions

Warm-Ups begin immediately after completion of the morning sessions but not before 12:00 Noon and end after 50 minutes

Timed Finals will not begin before 1:00 PM
