

A-MAY-ZING MEET
Blue Ridge Short Course Season Opener

- Site Information:** The competition pool is an eight lane, 25 yard course featuring nine-foot wide lanes separated by non-turbulent lane lines, paragon starting blocks, and a minimum pool depth of six feet and has been certified by USA Swimming. A Colorado electronic timing system and 8-lane scoreboard will be used. Warm-up and warm-down lanes will be available. Spectator bleacher seating is available. If chairs are brought to the meet, please keep all walk areas open for access by swimmers, other spectators, officials, etc. Please keep all food and beverages off of the pool deck. **The Town of Huntersville will charge a \$5.00 per day parking fee.**
- Rules:** The meet will be conducted in accordance with the current USA Swimming Rules and Regulations and NCS Official Handbook and the NCS Safety Program except where rules therein are optional and exceptions are herein stated. Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Classification:** Age Group closed league (Blue Ridge Swim League) meet. Age Group/Senior - 8 and under, 10 and under, 11-12, 13-14, and Senior.
- Eligibility:** Blue Ridge Swim League members properly registered with USA Swimming.
- Entries:** Submit entries on enclosed entry forms and summary sheets or on disk in Hy-Tek format with summary sheet, if possible. List swimmers' ages as of May 6, 2011. The North Carolina Swimming registration chair will check USA Swimming registration at least 5 days prior to the start of the meet. Only properly completed entry forms with payments on all fees will be accepted.
- Entry Limit:** A swimmer may enter **5 events each day plus relays**, for 13-14 and Seniors. For swimmers 12 & under, a maximum of **3 individual events** in your age group may be entered. 12 & under swimmers may also enter 2 Senior events.
- Entry Deadline:** All entries (properly completed forms and fees) must be received by **April 26, 2011**. Late entries may be accepted at the discretion of the Meet Director. **Late entries will be charged double entry fees and possibly may not be seeded.**

Awards: Medals places 1st through 3rd, Ribbons 4th through 8th individual and Medals places 1st and Ribbons 2nd through 3rd for relays. 13-14 and Seniors seeded together but awarded separately.

Scoring: This meet will be scored. Team scores will be sent with results.

Safety: The NCS Safety Program is in effect for this meet. Coaches are advised to supervise their swimmers at all times. NO running or horseplay will be tolerated.

Warm-Ups: For all sessions the schedule will be as follows:

The first 30 minutes will be general circle swim only. Team lanes will be assigned. No diving from the blocks or edge during this time.

The last 20 minutes are divided as follows:

Lanes 1 and 8 pace lanes

Lanes 2 through 7 racing starts from start end of pool, one way swim only, exit from opposite end of pool.

Coaches and Officials: There will be a coaches and officials meeting at 4:50 pm on Friday, May 6, in the hospitality room along with any officials briefing as well. All coaches and officials on deck must be registered and certified with USA Swimming. Meet Management will require all coaches and officials to show proof of certification / registration. Coaches and officials shall prominently display their registration cards while on deck.
